

## SCOTTISH TERRIER CLUB OF CHICAGO, INC.

### APPLICATION FOR PLACEMENT OF A SCOTTISH TERRIER RESCUE DOG

The Scottish Terrier Club of Chicago, Inc. has established a program of retrieving Scottish Terrier Dogs from person, humane societies or other institutions who no longer desire to have or keep such a dog. To apply for placement of such a dog the applicant must do the following:

- A. Sign this Application form and return it to the duly authorized representative of the Scottish Terrier Club of Chicago, Inc., whose name and address appear at the bottom of the application.
- B. Complete and return the attached questionnaire together with the application to the representative.
- C. That upon placement of a Scottish Terrier dog with you, you will be required to execute a written agreement which provides with limitation, the following:
  1. That you will provide the dog with a permanent home.
  2. That, if you are unable to keep the dog you will return it to a designated officer, agent or representative of the Scottish Terrier Club of Chicago, Inc. That in no event should the dog be sold by you or given to another person or placed in an animal shelter or humane society.
  3. That you will properly house, feed, water, exercise, care for and provide immunizations or other veterinary care, as the dog requires.
  4. That you will exercise proper control and restraint over the dog at all times and not allow the dog to run at large.
  5. That in the event the dog is not spayed or neutered, you will have the dog spayed or neutered within 60 days of placement and provide the representative of the Scottish Terrier Club of Chicago, Inc., a veterinarian certificate documenting the spaying or neutering.
  6. That the dog shall never be used for breeding or any experimental purposes.
  7. That you will notify the representative of the Scottish Terrier Club of Chicago if the dog is ever lost or stolen.
  8. That you will allow representatives of the Scottish Terrier Club of Chicago, Inc., to check the dog and its environment.
  9. That you will sign a release of liability and indemnification waiving any claim you may have against the Scottish Terrier Club of Chicago, Inc., its officers, agents or representatives from and against any injury which the dog may cause to any person or property after its placement with you.
- D. That you acknowledge and understand that the placement of any dog with you is at the sole discretion of the Scottish Terrier Club of Chicago, Inc., or its duly authorized officers, agents or representatives to place a dog with you.
